- **6**. Distribution of the net profit of 2024 and determining the amount of dividends, the form, term and procedure for its payment:

- 8. Extension, renewal or termination of the employment contract with the General Director of the Company;
- **9**. Selection of an external auditor for the mandatory audit of financial and economic activities of the company for the year ending 2025 and setting the maximum amount of remuneration to be paid to him.
- **10**. Approval of agreements (transactions) with affiliates of the Company, which may be concluded in the future in the course of daily economic activities
